APPLICATION NO: 22/00872/FUL

DESCRIPTION: Construction of single storey extension to existing bottling hall building

LOCATION: Cotswold Distilling Company, Phillips Field, Whichford Road, Stourton, Shipston-on-Stour.

Thank you for consulting the Cotswolds Conservation Board ('the Board') on this proposed development, which would be located within the Cotswolds National Landscape.¹

In reaching its planning decision, the local planning authority (LPA) has a statutory duty to have regard to the purpose of conserving and enhancing the natural beauty of the National Landscape.² The Board recommends that, in fulfilling this 'duty of regard', the LPA should: (i) ensure that planning decisions are consistent with relevant national and local planning policy and guidance; and (ii) take into account the following Board publications³:

- Cotswolds Area of Outstanding Natural Beauty (AONB) Management Plan 2018-2023 (link);
- Cotswolds AONB Landscape Character Assessment (<u>link</u>) particularly, in this instance, with regards to Landscape Character Type (LCT) 19 (Unwooded Vale) which the site is located within and 1 (Escarpment Outliers) and 6 (Ironstone Hills and Valleys) from which the site can be viewed;
- Cotswolds AONB Landscape Strategy and Guidelines (<u>link</u>) particularly, in this instance, with regards to LCT 19 (<u>link</u>), including Section 19.1, LCT 1 (<u>link</u>) including Section 1.1 and LCT 6 (<u>link</u>);
- Cotswolds AONB Local Distinctiveness and Landscape Change (link); and
- Cotswolds Conservation Board Position Statements (link).

Having reviewed the application, we consider that the proposal would not result in a significant impact on the landscape and scenic beauty of the National Landscape.

We agree with the applicant's assessment that the proposed extension to the bottling hall is of limited scale and will be subservient to the current bottling hall. The proposed materials reflect those already used in other buildings on site and the extension would have a limited impact upon the public right of way to the west due to the intervening hedgerow whilst also be screened from the road by other buildings on site. The proposal would not affect the current operating hours, levels of traffic movements or noise generated by the site and therefore would not have a significantly greater impact on the tranquillity of the AONB compared with the current site operations.

Bearing the above in mind, the Board does not wish to object to this application.
