Thank you for consulting the Cotswolds National Landscape Board¹ ('the Board') on this proposed development, which would be located within the Cotswolds National Landscape².

In reaching its planning decision, the local planning authority (LPA) has a statutory duty to have regard to the purpose of conserving and enhancing the natural beauty of the National Landscape.³ The Board recommends that, in fulfilling this 'duty of regard', the LPA should: (i) ensure that planning decisions are consistent with relevant national and local planning policy and guidance; and (ii) take into account the following Board publications⁴:

- Cotswolds Area of Outstanding Natural Beauty (AONB) Management Plan 2023-2025 (link);
- Cotswolds AONB Landscape Character Assessment (<u>link</u>) particularly, in this instance, with regards to Landscape Character Type (LCT) 9 (High Wold Dip-Slope);
- Cotswolds AONB Landscape Strategy and Guidelines (<u>link</u>) particularly, in this instance, regards to LCT 9 (link) including Section 9.2;
- Cotswolds AONB Local Distinctiveness and Landscape Change (link); and
- Cotswolds Conservation Board Position Statements (link).

The Board **does not object** to this application. The application seeks permission to vary consented plans to enable a larger extension to the existing workshop than has currently been permitted to respond to the evolving needs of the applicant's business. The application site is located within an established industrial area which is surrounded on three sides by bunds supplemented by established planting. Having reviewed the applicant's submission we agree with the applicant's assessment that due to the presence of the bunds and the larger buildings to the north, the proposed larger extension would not give rise to significant adverse landscape impacts over and above the currently-consented workshop extension. The external finishes proposed will match those of the existing buildings.
